Please be advised that the County of San Diego Department of Environmental Health and Quality Solid Waste Local Enforcement Agency has received and approved a Report of Facility Information (RFI) Amendment per Title 27, California Code of Regulations (27 CCR), Section 21665(c). This public notice was prepared pursuant to 27 CCR Section 21660.1.

Project Description

El Corazon Compost Facility is an existing compostable materials handling facility permitted under a full Solid Waste Facilities Permit issued on January 29, 2018.

As a result of the facility's 5-Year Permit Review, the amendment to the RFI, in the form of a Report of Composting Site Information (RCSI), corrects grammatical errors, reflects a new Accessor Parcel Number (APN), incorporates reference to physical contamination sampling requirement and a description of the organic waste measurements and record keeping procedures required pursuant to SB-1383 Short-lived Climate Pollutants: Organic Waste Reductions regulations, and updates terminology in the Odor Impact Minimization Plan for consistency with RCSI.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current Solid Waste Facilities Permit.
