Please be advised that the County of San Diego Department of Environmental Health and Quality Solid Waste Local Enforcement Agency has received and approved a Report of Facility Information (RFI) Amendment per Title 27, California Code of Regulations (27 CCR), Section 21665(c). This public notice was prepared pursuant to 27 CCR Section 21660.1.

Project Description

EDCO Station is an existing solid waste transfer station/material recover facility under a full Solid Waste Facilities Permit issued on July 29, 2022. The application package to amend the RFI, in the form of a Transfer Processing Report, requests the following changes:

- Updated table to reflect change of hours and days for Refuse Receiving – Public and Buy-Back Center Operations, specifically:
 - Extend Refuse Receiving – Public Saturday Operations from 5:00 a.m. to 4:30 p.m.
 - Extend Buy-Back Center Operating Days to include Monday from 10:00 a.m. to 4:00 p.m.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current Solid Waste Facilities Permit.
