Please be advised that the County of San Diego Department of Environmental Health and Quality Solid Waste Local Enforcement Agency has received and approved a Report of Facility Information (RFI) Amendment per Title 27, California Code of Regulations (27 CCR), Section 21665(c). This public notice was prepared pursuant to 27 CCR Section 21660.1.

Project Description

EDCO Recycling is an existing solid waste transfer/processing facility under a full Solid Waste Facilities Permit issued on December 10, 2015. The application package to amend the RFI, in the form of a Transfer Processing Report, requests the following changes to reflect the installation of a new load out truck scale, updated site map and description of onsite traffic circulation, and a description of the organic waste measurements and record keeping procedures required pursuant to SB-1383 Short-lived Climate Pollutants: Organic Waste Reductions regulations.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted California Environmental Quality Act (CEQA) documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current Solid Waste Facilities Permit.
